

Extended Warranty Agreement

If **You** purchased a 1 day, 6, 12 or 24 month Extended Warranty and **You** have paid **Us** the Extended Warranty charge, **We** agree with **You** as follows:

All terms and conditions stated in the General Auto Parts "Warranty Information" section, attached to **Your** original invoice apply to this Extended Warranty, and subject to the following additional terms and conditions:

1. For 1 day, 6, 12 or 24 month coverage, this Extended Warranty begins on the date of **Your** original invoice and shall end 1 day, 6, 12 or 24 months after **Your** original invoice date and covers one repair or one replacement of the part or **Assembly** described on **Your** original invoice.
2. **We** have no obligations to anyone except to the customer named on the original invoice. This Extended Warranty is (a) non-transferable, and (b) non-refundable after the part or Assembly has been installed in a Vehicle.
3. This Extended Warranty covers labor only to the extent described below in the definition of "**Labor**".
4. For the "**Labor**" to be valid, **Your** original paid invoice must indicate on the front "Parts & **Labor** Extended Warranty".
5. For this Extended Warranty to be valid, **Your** original paid invoice must indicate (a) the coverage period of 1 day, 6, 12, 24 months, (b) the coverage type of either parts only or parts & **labor**, and (c) the accurate odometer mileage of the **Vehicle** as of the date of the invoice.
6. Mileage is limited as follows during the applicable Extended Warranty period:
 - If **You** purchased 1 day of Extended Warranty coverage, the Extended Warranty will terminate on the earlier of 1 day after the date of **Your** original invoice or 33 additional miles on the **Vehicle's** odometer. The 1 day of coverage is only offered and valid on parts sold and installed by General Auto Parts, after the 1 day coverage has expired, the part will continue to be covered under the standard 90 day part warranty until its expiration.
 - If **You** purchased 6 months of Extended Warranty coverage, the Extended Warranty will terminate on the earlier of 6 months after the date of **Your** original invoice or 6,000 additional miles on the **Vehicle's** odometer.
 - If **You** purchased 12 months of Extended Warranty coverage, the Extended Warranty will terminate on the earlier of 12 months after the date of **Your** original invoice or 12,000 additional miles on the **Vehicle's** odometer.
 - If **You** purchased 24 months of Extended Warranty coverage, the Extended Warranty will terminate on the earlier of 24 months after the date of **Your** original invoice or 24,000 additional miles on the **Vehicle's** odometer.

We have no obligations under this Extended Warranty if the mileage limitations described above are exceeded.

KEY TERMS: (When used, Key Terms will appear in dark print) "**You**" and "**Your**" mean the **Repairer/Parts Reseller** (Customer) named on **Your** original General Auto Parts invoice. "**We**", "**Us**", "**General Auto Parts**" and "**Our**" mean General Auto Parts llc. 715 Kennon Rd, Rockford, IL 61109.

"**Assembly**" applies to an engine (including only the cylinder block, cylinder heads and all internal lubricated parts) and/or the transmission (including only the case, torque converter and all internal lubricated parts) and/or front axle or rear axle (including housing, knuckles, axles shafts, internal gears, electronic control unit and bearings) and/or transfer case (including internal components and internal electronics) and/or carrier assembly (including gear set, case with non-removable stub axles and flanges) purchased by **You** for resale and/or for installation in a **Vehicle** to be used for private passenger use.

"**Breakdown**" means the failure of the part or **Assembly** described on **Your** original invoice due to a defect in material.

"**Repairer**" means an independently owned and operated Licensed Repair Facility located in the United States.

"**Vehicle**" means the car or light truck in which the part or **Assembly** was originally installed.

"**Labor**" means General Auto Parts will reimburse the **Repairer** up to \$50.00 per hour for the repair of a part or **Assembly** covered by this Extended Warranty. These charges shall not exceed (a) 100% of the part price as indicated on **Your** original invoice, and (b) the applicable number of hours derived from labor allowances from nationally recognized labor time allowance manuals.

At Our discretion, replacement parts used in covered repairs may include remanufactured, new, used, non-original equipment manufacturer or aftermarket parts that meet our quality standards. Replacement part or Assembly mileage may be equal to or greater than that of the original part or Assembly purchased from Us.

WHAT THIS EXTENDED WARRANTY DOES NOT COVER:

The General Auto Parts "Warranty Information" attached to **Your** original invoice contains important terms, conditions, limitations and exclusions that apply to this Extended Warranty. This Extended Warranty will immediately terminate upon the occurrence of any of the events described in the "Warranty Information" section of the General Auto Parts invoice, under the caption "All Warranties & Refunds are Null and Void if:"
